1. The borrower agrees to report any accident, malfunction, damage or breakdown of the Nex-Tech Grill to Nex-Tech, and further acknowledges that continued use of the Nex Tech Grill following such accident, malfunction, damage or breakdown shall be at the borrower's sole risk and liability.
2. The borrower acknowledges that he/she has been properly trained on the setup and use of the Nex-Tech Grill, and any questions pertaining to such were adequately answered by Nex-Tech before borrower assumed possession.
3. The borrower agrees not to use, or permit the use of, the Nex-Tech Grill:
 - a. for any unlawful purpose
 - b. in a careless or negligent manner; and
 - c. without appropriate adult supervision to ensure safety
4. The borrower agrees to use the Nex-Tech Grill only for the purposes provided herein.
5. Nex-Tech shall not be held liable for damages, inconvenience or time lost caused by accident, breakdown or malfunction of the Nex-Tech Grill. The borrower agrees to indemnify and hold harmless Nex-Tech and its owners, agents, affiliates, managers, successors, assigns and personnel (collectively referred to as "affiliates") from and against any and all claims for loss of or damage to property or injury to person(s), including death, resulting through the use, operation or possession of the Nex-Tech Grill.
6. The Nex-Tech Grill is stored at the Nex-Tech Hays location. Borrower agrees to pick up and return the grill to the Hays location. Borrower agrees to return grill within 24 hours of use to ensure that other reservations are fulfilled.

This Agreement represents the entire understanding and agreement between Nex-Tech and the borrower with the regard to the subject matter hereof.

We have read this Agreement, fully understand the terms and conditions set forth herein, and warrant that we are authorized to execute this Agreement on behalf of the parties hereto.

Nex-Tech Grill Procedures

Please follow these procedures to ensure proper handling:

1. Review, sign, and return the Nex-Tech Grill Agreement Form
2. Borrower will be responsible for transportation of the Nex-Tech Grill to and from the event
 - a. Will need a vehicle with a 2" ball hitch to transport the Nex-Tech Grill
 - b. Grill will be located at the Nex-Tech office in Hays (2418 Vine Street)
 - Will need to be cleaned and returned to this location within 24 hours
 - c. Arrangements for pick up can be made when Borrower is notified of approval
3. The Nex-Tech Grill runs by propane and will be filled prior to your event

Lighting the Grill: Preheat Prior to Grilling

1. Use caution when lighting the grill
2. Turn on propane bottle on the same side you will be grilling (if using both sides, turn on both bottles)
3. Turn on the red valve near the propane bottles
4. Turn on all three valves beneath the panel on the side of the grill (the valves bring gas to each respective burner)
5. To light, use the butane lighter located in a tub in the rear compartment of the grill
 - a. If using a long lighter, stick it through the hole on the side panel of the grill to light the grill
 - b. If using a short lighter, raise each grill grate manually and stick the lighter into the grill where the burners are located
6. There are gloves available in the rear compartment to assist you in lifting the grate

Grilling

1. Keep a squirt bottle of water on hand to extinguish large flames
 - a. You may notice that one side of the grill heats better than the other, cook accordingly

Clean-Up

1. Wipe down outside of grill with cleaner and paper towels/rags (kept in the rear grill compartment)
 - a. Formula 409 or any stainless steel cleaner may be used
2. Clean grill grates
